### OPTION I

You have the right to **request** Driving Safety Course. You will lose that right if you do not provide written notice to the Court **on or before your appearance date**. Only one (1) charge may be dismissed by taking a DRIVER SAFETY COURSE OR MOTORCYCLE OPERATOR TRAINING COURSE.

**By signing the reply form you certify below that you:**

- A) have not taken a driver safety course or motorcycle operator safety course within the 12 months preceding the date of this offense and are not in the process at this time; and
- B) were not speeding 95 miles per hour or more; and
- C) were not speeding 25 miles per hour or more over the posted speed limit; and
- D) were not cited in a construction zone with workers present; and
- E) do not hold a Commercial Driver's License (CDL) or a CDL Permit.

(  ) I hereby enter a plea of (  ) Guilty (  ) Nolo Contendere and **request** to take a driver safety course or motorcycle operator safety course **and include the following items with this form:**

- 1) a copy of your valid Texas driver's license OR active military ID along with your State issued DL;
- 2) a copy of your proof of insurance with your name listed on the insurance card; and

**If you fail to appear, an additional charge may be assessed against you for Violate Promise to Appear and a warrant will be issued for your arrest with additional fees.**

**JUVENILE WARNING**

- 1) A child and parent required to appear before the court have an obligation to provide the court in writing with the current address and residence of the child. The obligation does not end when the child reaches age 17. On or before the seventh day after the date the child or parent changes residence, the child or parent shall notify the court of the current address in the manner directed by the court. A violation of this subsection may result in arrest and is a Class C misdemeanor. The obligation to provide notice terminates on discharge and satisfaction of the judgment or final disposition not requiring a finding of guilt.
- 2) If an appellate court accepts an appeal for a trial de novo, the child and parent shall provide the notice to the appellate court.
